MINUTES CITY BOARD OF EDUCATION CITY OF MUSCLE SHOALS, ALABAMA

The City Board of Education of the City of Muscle Shoals, Alabama, met for the Board's regular meeting in the office of the City Superintendent of Education of the City of Muscle Shoals, Alabama, on January 21, 2021, at approximately 6:22 p.m. The meeting followed a work session held at 5:30 p.m. Due to the COVID-19 pandemic, the meeting was held in blended live and virtual format. The secretary called the roll with the following results:

Also physically present were supervisors Dennis Conner, Kevin Stephenson, and Richard Templeton. Muscle Shoals Education Association representative, Lori Roberts, was also physically present. Others physically present included school system Teacher of the Year (TOY) recipients and their family members. Cassie McConnell, Highland Park Elementary School TOY, was virtually present.

President Stoddard declared a quorum present and the meeting duly and legally constituted and open for the transaction of business.

II. <u>School Presentation – Howell Graves Preschool</u>

Superintendent Holden recognized Principal Sheneta Smith who provided a video

presentation highlighting achievements from Howell Grave Preschool.

III. <u>Superintendent's Report/Announcements</u>

- There are nearly 10,000 fewer public school students in Alabama than there were last year. The significant decrease in enrollment is largely due to the COVID-19 pandemic as parents chose to either keep their children at home, seek virtual learning options, or enroll them in private school. Muscle Shoals held steady despite seeing a slight decrease in enrollment. The ALSDE is working to make sure that districts do not experience a huge decrease in funding where decreases in enrollment exist.
- Word was received late last week that Muscle Shoals City Schools would receive almost \$20,000 to provide a summer reading program and summer reading camps for students. This funding is especially important as we work to meet the high expectations of the Alabama Literacy Act.
- Congratulations were given to Monica Jeffreys and the Community Education Program for being awarded Dependent Care Development Grants in the amount of \$64,500. Highland Park, Howell Graves, Muscle Shoals Middle, and Webster will all receive \$16,125 toward their extended day programs.
- January is School Board Appreciation Month. On behalf of the entire school system, Dr. Holden thanked board members for their outstanding service, especially during the most challenging school year ever. Boards of education are made up of ordinary, everyday working people doing extraordinary work in moving school districts forward, and the Muscle Shoals Board is no different. They are five outstanding individuals who are committed to excellence in education.
- Superintendent Holden ended with a quote from Dr. Martin Luther King, whose birthday was just celebrated this week: *"The function of education is to teach one to think intensively and to think critically. Intelligence plus character that is the goal of true education."*

Whereas, the draft Northwest Alabama Multi-jurisdictional Hazard Mitigation Action Plan was advertised at a public hearing during its development and again following review by the Federal Emergency Management Agency and the Alabama Emergency Management Agency;
